## **Albuquerque's Immigrant Youth Denounce Trump's Enforcement & Deportation Plans, Launch Petition For Local Safety Policies For All Immigrants**

*Mayor Richard Berry, Albuquerque's City Councilors & People of Conscience Must Affirm Commitment to Create Safety Policies and Organize to Undermine Trump's Dangerous Agenda As It Begins*

**ALBUQUERQUE, N.M.-** Today marks the beginning of Trump's deportation plans after signing a series of executive orders mandating DHS to build a wall with México, emboldening ICE's authority and discretion when persecuting immigrants, calling for collaboration between local authorities and immigration agencies, and undermining sanctuary policies and cities that provide protection for immigrant families across the states.

These policies have all roundly been criticized for years for relying on or leading to increases in racial profiling in the workplace and in communities. In our state, New Mexicans have been fighting against an anti-immigrant Martinez administration for the past six years. Currently Albuquerque is not considered a "sanctuary" city since current Mayor Richard Berry took office in 2009.

Yesterday it was announced that Rep. Patricia Roybal Caballero will introduce a bill that will halt, state and local law enforcement agencies, from using state or federal resources "for the purpose of detecting or apprehending persons whose only violation of law is that they are persons of foreign citizenship who have entered or are residing in the United States in violation of federal immigration laws."

**Gabriela Hernandez, lead LGBTQ organizer with United We Dream and member of the New Mexico Dream Team said:**

“These executive actions on immigrants have made it clear that he will try to rule using race-based intimidation and leave immigrants, black people and Muslims living in fear of police, their employers and faceless bureaucrats.

“True security for me means my family and loved ones are able to be safe, live freely and thrive. That’s why we’ve launched a petition calling on Mayor Richard Berry to affirm his commitment to creating safety policies for immigrants, Muslims and black people and members of the LGBTQ community.

**Felipe Rodriguez, undocumented Albuquerque resident and lead coordinator for the New Mexico Dream Team added,**

“Our localities should not let themselves be bullied, by the Trump administration, into sacrificing the safety and unity of our immigrant families. Currently in our state, Rep. Patricia Roybal Caballero introduced a House Bill 116, which halts local authorities across the state from cooperating with immigration agencies for the purpose of identifying and persecuting immigrants.

“An attack on one of us is an attack on all of us — so we will fight to pass these type of policies and find more ways for our communities to thrive because we are #HereToStay and organizing to win in spite of Trump’s agenda of fear and intimidation.”
